Mark Erickson

Mark Erickson is the Economic Development Authority Director for the city of Winthrop, Minnesota. He served as city administrator from 2008 to 2014 and worked closely with the RS Fiber Cooperative project in Sibley, Renville, Nicollet and McLeod counties in Minnesota.

Prior to Winthrop Mark was employed by Hiawatha Broadband Communications in Winona, Minnesota, working with communities interested in building a Fiber To The Home networks.

Mark currently serves on the RS Fiber Cooperative Board of Directors, the Minnesota Municipal Utilities Association Board of Directors and chairs the League of Minnesota Cities Telecommunications Task Force. He is a former member of the CK Blandin

Foundation's Telecommunications Strategy Board.



Joe Buttweiler

Joe Buttweiler with Consolidated Telecommunications Company (CTC) is actively involved in the promotion and deployment of broadband services to all areas of Minnesota. At CTC Joe's role is to develop strategies and partnerships which will expand broadband services to those without access and to those seeking improved access. Joe's background originates in the electric industry having spent time at working for a Generation & Transmission Cooperative and at Arrowhead Electric Cooperative in Northeastern Minnesota. While at Arrowhead Joe oversaw the electric cooperatives Fiber to the Premise project which now provides speeds up to 1GB to cooperative members and to others in the Arrowhead region.

"Our agricultural, educational and health care delivery systems are all enhanced when rural people are connected. Public funding is necessary to support continued private

investment to enable further broadband deployment. As we work to connect the most rural areas we need access to public funding which will provide up to \$4 of public investment for every \$1 of private investment."



Marc Johnson

Marc Johnson is Executive Director of East Central Minnesota Educational Cable Cooperative (ECMECC), a telecommunications & technology cooperative of 14 K-12 school districts in East Central Minnesota. Marc is in his ninth year as ECMECC director having spent two years prior as technology director for ISD 15 and seven years as instructional technology specialist for the St. Croix River Education District. Previously, he taught middle and high school mathematics and college technology courses. Marc has been co-chair of the Kanabec Broadband Initiative since its inception in 2011 and continues to work with several other rural broadband initiatives in East Central Minnesota.

"Our current provider and other potential providers have told us that there is not a market case to build our rural areas – even with the assistance of a long-term, low interest loan from the county. Additional public funding to go along with a provider investment and the residential "take" seems to be our only hope of getting higher speeds."



Chuck Novak

Chuck Novak is the current Mayor of the City of Ely, winning his most recent run on a platform of economic development with the extension of broadband to Ely as a priority in making that happen.

"Economies in rural Minnesota cannot grow businesses unless true high speed internet is available. Legislators need to get educated in what the term Broadband really means."
