Installation Fee \$150 for first 250' with customer digging/trenching for and installing conduit from landhold to house City provides materials

ONT Rental Fee \$10 month.

Monthly Charge \$60 for up to 100mbps

Bad Check Charge \$35/check

Costs of collection or recovery of ONT from customer including but not limited to a reasonable attorney's fee shall be paid by Customer/Property if such are incurred by City/CCN.
